# 2005 State Aid Fund Approved Equipment List

**Providing all firefighters have NFPA compliant personal protective equipment.**

*All equipment should meet current standards for firefighting equipment.*

## **PRIOR APPROVAL**

The Fire Chief must request prior approval to purchase any of the items in this boxed area. This letter, memo, or email of request should be directed to the KY Fire Commission's Executive Director only, and that **approval reply must accompany the financial information submitted on behalf of your State Aid.**

All firefighters must have servicable turnout gear before requesting any of the following equipment for their fire departments.

- Any equipment that is used, but in working condition.
- Automatic defibrillator
- Carbon Monoxide detector
- Communication equipment
- Computer
- Copier
- Digital camera
- Encoder
- Heat sensor
- Internet service - (up to \$400 per year providing the fire department submits their incident reports and training records via the internet, and the bill is invoiced to and paid by the fire department.)
- Life jackets
- Printer
- Radio's
- Radon gas detector
- Repeater system
- Scanner
- Television
- Thermal imaging camera
- Training materials (manuals, books, tapes)
- VCR (for training purposes)
- Washer & Dryer (meets manufacturers recommendations for cleaning of turnout gear)

□ **Apparatus:** Any type, make, or size that is suitable for use in your jurisdiction. And, it should be compliant with the Insurance Service Office (ISO) to improve or maintain insurance ratings.

□ **Portable Fire Extinguishers:** Must be approved by the Underwriters Laboratories and rated for: A, B, C, or D, class fires or any combination thereof.

□ **Portable Pumps:** Pumps should be designed and manufactured for firefighting service and capable of producing a firefighting stream. Their intakes and outlets should be a minimum of 1 1/2", and dump tanks should be included.

## **STATE AID FUNDS CANNOT BE USED FOR:**

- Paying heat, electric, or water
- For daily maintenance of apparatus not associated with engine or transmission replacements
- For insurance on buildings, volunteer employees, or apparatus'
- Purchase of jackets, uniforms, or coveralls
- For surfacing of parking areas, or
- Alcohol.

*New Equipment must met NFPA standards:*

- NFPA #1977 Wildland FF Apparel (*Extrication suite- Only to be used for extrication, not as firefighting equipment. The Fire Commission is not responsible for injuries incurred if used during firefighting operations.*)

State Aid can be used for attending:

■ **Training at Fire Schools for the recruitment and retention of volunteer firefighters: Covering meals, hotel or motel rooms, application fees, and travel expenses, which must be submitted on the State Aid Proof of Purchase form by providing copies of checks, money orders, invoices, and meal receipts.**
